### Where the Mississauga Ontario Health Team is today

Thank you for your engagement and interest in this work over the last month. We hope you were able to attend both the webinar held on August 23 and the co-design sessions held on August 27.

More than 80 groups attended the webinar and more than 70 people from diverse areas of health care joined the co-design sessions to share their important perspectives, including patient and family advisors, primary care, acute care, home care, and community partners.



### Your input required: how we plan to work together

The vision for this Ontario Health Team (OHT) is to improve the health of people in our community by creating an interconnected system of care across the continuum, from prenatal care to birth to end of life. Thank you for your support in planning and design of this OHT to date.



**The Mississauga OHT is now at a stage where we need to confirm who would like to be a member of the future team.**

This is a non-binding decision at this time, but will help inform implementation planning and is required for the Full Application. We recognize that membership will continue to evolve as we finalize year one plans with the Ministry and move through to maturity.

The Ministry of Health (Ministry) envisions two kinds of OHT membership:

- **Member:** This group includes stakeholders who see opportunities to be involved in the day-to-day operations of the OHT and, at some point, see themselves as signing on as part of the accountability agreement with the Ministry.
- **Affiliate:** This group includes stakeholders who will endorse, support or provide advice to the OHT but would not be part of the future accountability agreement with the Ministry.
